9. Where are you based?

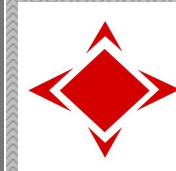
We are currently based in West Midlands, but our head office is based in Cornwall.

You will need to contact us using one of our contact method on our contact us web page to find out what our availabilities are.

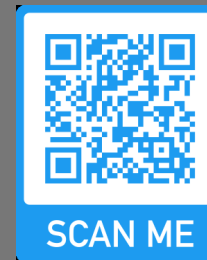
